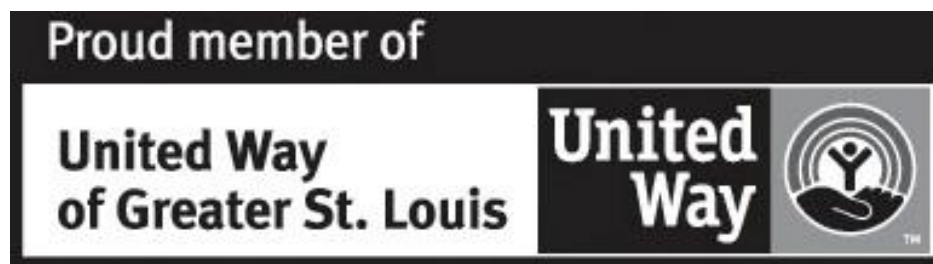

THE JOHN J. MCATEE AWARD

The John J. McAtee Police Recognition Award is presented to commissioned peace officers who have shown compassion, concern and understanding when dealing with persons with mental illness.

Nomination Rules:

1. Nominee **must** be a commissioned peace officer associated with a police department, sheriff's office, National Park Service, campus police department or a Missouri State Trooper assigned to or located in the City of St. Louis or St. Louis, St. Charles, Lincoln, Warren, Jefferson or Franklin counties.
2. The act cited must have involved someone with a psychiatric illness **and** the officer went **above and beyond** the call of duty in working with the person, providing outstanding compassion and service.
3. A police department supervisor or an employee of a mental health agency, hospital emergency room or social service agency that has knowledge of the act or acts must nominate the officer.
4. The act must have taken place between April 1, 2008 and March 31, 2009.
